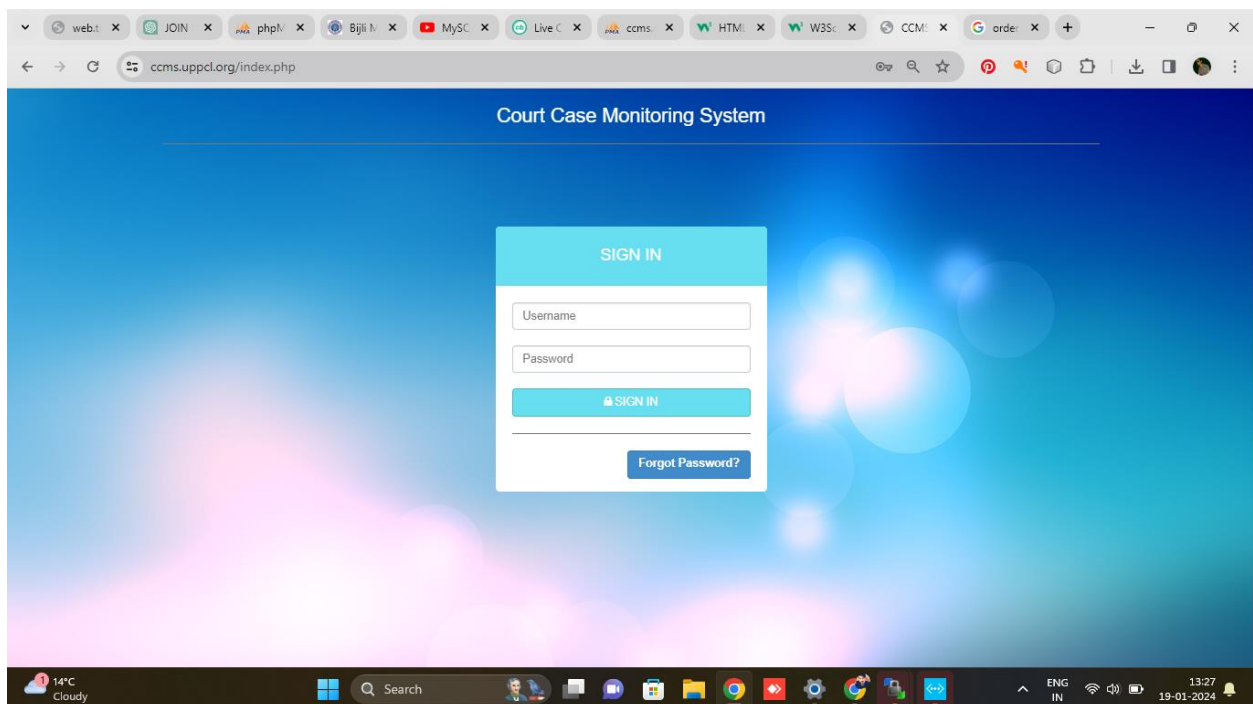


CCMS USER MANUAL (SOP)

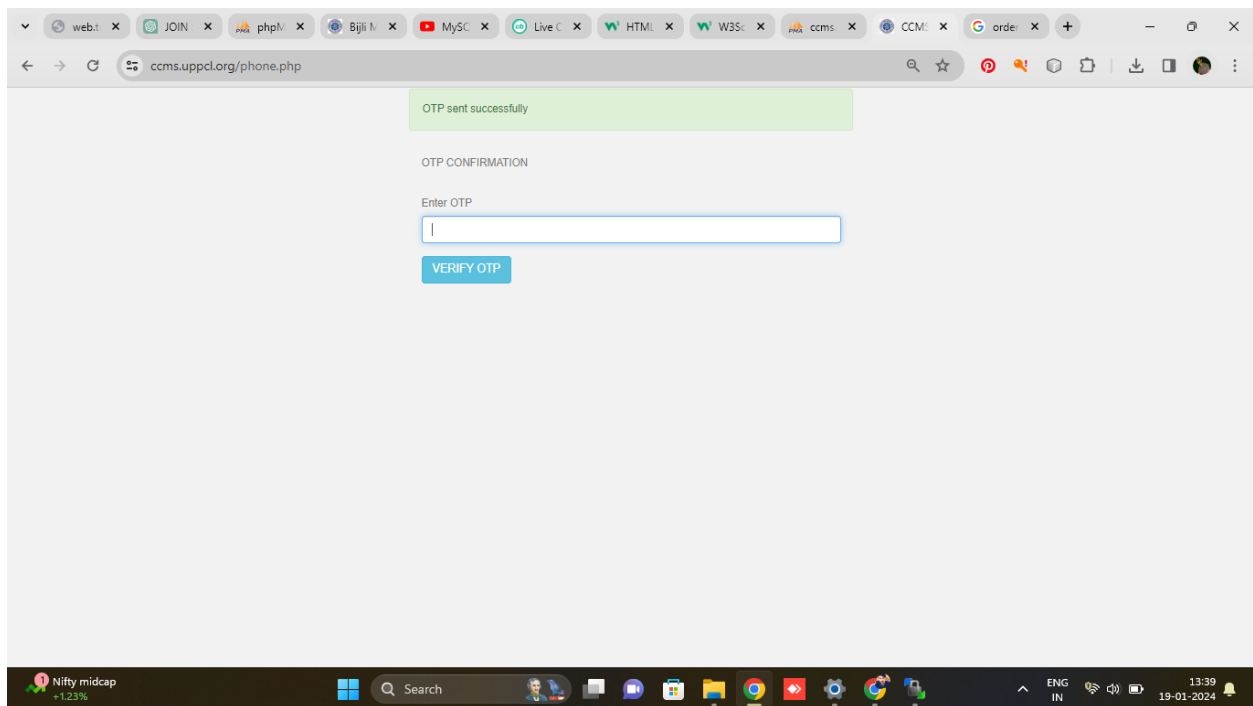
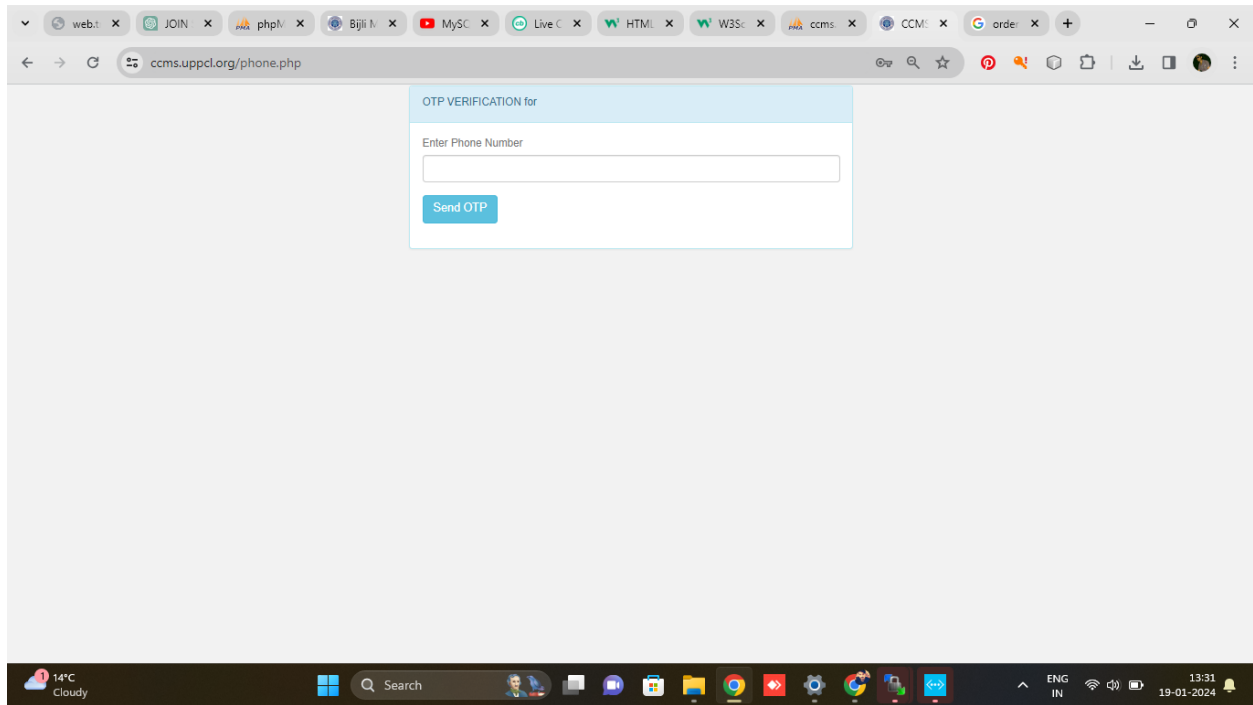
CCMS Portal for the monitoring of court cases registered with the High Court or Supreme Court at the division level, is developed by the UPPCL in-house development team.

This portal provides the login at the division level for the feeding of pending court cases and the updation of cases with the further court dates, as well as the Headquarter level for the monitoring of all the registered court cases.

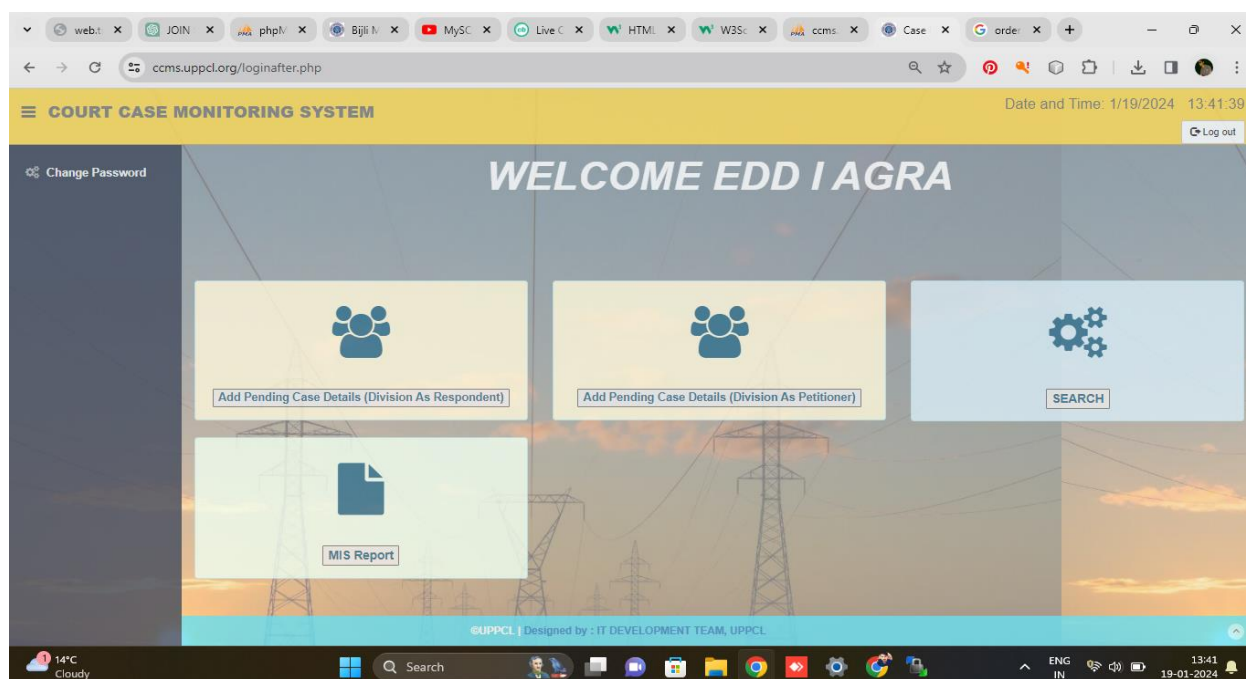
Court Case Monitoring System Login Page:



Portal provides the facility of first time login password change with the help of OTP through mobile number that login user wants to register.



After the successful first time password change, users can make a login with the new password to land on the CCMS portal dashboard.



At the dashboard, users at the division level get to add pending case details either division as a respondent or division as a petitioner.

Pending case details form contains following entries:

1. Unique Case Id: It will be a combination of Case Type + Court Name + Case Number + Year.
2. Case Type: The type of the case registered with the court
3. Court Name: Type of the court:- High Court (Lucknow,Allahabad), Supreme Court
4. Case Number: Number assigned to the case
5. Year: Year in which the Case was registered
6. Nature Of Dispute: Cases is related to which department
7. Advocate Name: Name of the Advocate who is handling the case
8. District: Case related District
9. Case Status: It would be pending for the first time registration in the portal
10. Case Filed Date: Date in which the case was filed
11. Respondent Details: Details of the respondent against whom case was filed
12. Petitioner Name: Name of the petitioner who filed the case

13. Upload Document: Document having details of (Writ, Index, Petitioner/Respondent Details, Prayer, etc.) in single PDF

14. Short Description Of Case: Description of the case with at least 200 characters and maximum 1000 characters can be filled.
